LEGAL CONDITIONS FOR APPLYING FOR AND USING CHILDREN'S PASSES FOR ENTRY TO THE "CAMP NOU".

1. GENERAL CONCEPT AND CONDITIONS TO BE A BENEFICIARY

- 1.1 The passes issued in relation to the project titled "Children at the Camp Nou" relate to an initiative set up by FÚTBOL CLUB BARCELONA (hereinafter FC BARCELONA) to facilitate and encourage attendance by children of matches at the "Camp Nou" as long as the stadium capacity so permits.
- 1.2 These passes are aimed at and are available to children aged 14 years or younger that satisfy the following conditions: (i) be club members themselves or the children or grandchildren of club members; (ii) not have a season ticket; and (iii) they and/or the adult member associated to the application are (in the case of members) up to date with payment of membership fees and other financial obligations with regard to the club.
- 1.3 Each pass is personal and non-transferable and is issued for use only and exclusively by the previously identified minor and this minor may only enter the stadium if accompanied by the adult member, who must have their own match ticket or season ticket to gain entry to the stadium.
- 1.4 Transfer of the pass is strictly forbidden, neither onerously or for free. Failure to comply with this condition, and therefore detection by the Club that someone has entered or attempted to enter the Camp Nou using a pass for which they are not the beneficiary who applied for the same, may lead to the application of the same disciplinary measures as those stipulated for season tickets in the Fútbol Club Barcelona Statutes, which have been accepted by and are binding to all club members.

2. PROCEDURE FOR APPLYING FOR CHILDREN'S PASSES

- 2.1 The application for a pass must necessarily be made by an adult with member status and that is the progenitor or grandparent of the non-season ticket holding child, who is thus the beneficiary of the pass being applied for thereby. Therefore, this operation may only be undertaken with the full knowledge and consent of the adult holding the aforesaid status.
- 2.2 Each member may make one application for the children's pass for each match included in the "Children at the Camp Nou" scheme.
- 2.3 There are two methods for making applications for passes:

a) By applying for the same using a form available on the Club website from six (6) days before the match until half-time in the same, where the legal terms and conditions must also be accepted by the adult responsible for the application for a pass on behalf of the child.

The following details must be provided in order to access the application form: (i) The password and personal code of the adult member applying for a pass on behalf of the child.

- (ii) Additionally, the following details will be requested:
 - ✓ Name and Surname of the child
 - ✓ Age of the child
 - √ Adult's mobile telephone number
 - ✓ Adult's national ID number
 - ✓ Adult's email address
- (iii) Finally, the adult member's commitment/obligation to accompany the child shall be requested. In this regard, the adult that fills in the form shall be responsible for the application for a children's pass and the use made of it, who also agrees to accompany the child to the game, assuming personal responsibility for any possible consequences of not complying with this obligation. The adult expressly exempts the Club from any responsibility with regard to the minor.
- b) Make the transaction in person at the Club ticket offices from six (6) days before the match until half-time in the same.
- 2.5 Any application for a pass is always subject to the availability of free seats from among the number of the same allocated by the Club for said purposes. It is therefore advisable to check for the availability of seats and to apply for the pass before travelling to the stadium or its vicinity.
- 2.6 Once the application has been made and if there are free seats, then the system will send a confirmation email along with the pass, which should be printed and said hard copy must be brought physically on the day of the match. At the time of confirmation, the system will indicate the Stadium gate through which the child should enter with the pass, which must necessarily be located in the same sector as that in which the adult member that made the application has a match ticket or season ticket. Both the adult and the minor must enter together through the gate assigned to the minor.
- 2.7 Each adult may only enter the stadium with one (1) minor carrying a pass under the conditions and limitations established in this document.

The adult that applied for the pass agrees to accompany and assumes responsibility for accompanying the minor to the stadium and to exercise custody of the same both during entry to the stadium and while inside the premises of the "Camp Nou"; and exonerates FÚTBOL CLUB BARCELONA from any responsibility derived from failure by the adult to comply with this obligation.

- 2.8 There are some matches that are considered high risk and are excluded from the Children at the Camp Nou project, and therefore passes MAY NOT be requested for these. These matches, in principle, are:
 - ✓ Real Madrid and Atlético Madrid in the league or cup.
 - ✓ Knockout matches in the UEFA Champions League.
 - ✓ Either leg of the Spanish Super Cup.

The Club reserves the right to exclude any additional matches when circumstances concur that, in accordance with the Club's own criteria, make it advisable for children with passes not to attend the same.

2.9. Should a member be in arrears with payments and should there be any outstanding amount with regard to their membership fees, then that member shall lose all rights to apply for passes until the situation is rectified.

3. OPERATION FOR ENTRANCE WITH A CHILDREN'S PASS ON MATCH DAY

- 3.1 Each pass includes a barcode that permits the child to enter the Stadium through the gate determined in the confirmation message. This gate must necessarily be located in the same section as that where the adult member that made the application has their match ticket or season ticket. Both the adult and the child must enter the stadium through the gate assigned to the minor. Only one minor may enter with each adult.
- 3.2 The adult accompanying the child must have a ticket for the match in question, or a season ticket that has not been released back to the Club through the Seient Lliure scheme.
- 3.3 The adult applicant is under all circumstances responsible for the child carrying the pass, not only with regard to the process for applying for the same but also throughout the operation and the circumstances involved in its use, access to the stadium and safeguarding and having custody for the child throughout the match.

4. PROTECTION OF PERSONAL DETAILS

- 4.1 Pursuant to Spanish Organic Law 15/1999, of December 13 on the Protection of Data of a Personal Nature (LOPD), and associated regulations and amendments to the same, the CLUB informs the adult applicant for a pass, and this person ACCEPTS AND AUTHORISES THE CLUB, that the data provided on this form relating both to the applicant and to the minor for whom the pass is requested, shall be used by FC BARCELONA in order to:
- a) check that the details provided on the application form are the same as those in the membership database (which constitutes an authorised file for which the CLUB is the responsible party).
- b) enter in the aforesaid database any data provided in the application form that is not already included in the digital file for which FC BARCELONA is the responsible party, that data being considered to be confidential.
- c) treat said data in such a manner that the CLUB may make any announcements that it considers adequate either directly or through third parties that are authorised to do the same, in relation to: (i) the Senior Passport; (ii) any other matter of interest in relation to sporting and/or social and/or other events that the Club might organise and develop in compliance with its statutory purposes; (iii) information and or commercial announcements regarding any type of products, services, promotions or events either of FC BARCELONA or of any of its sponsors and/or partners that could be of interest to the member.
- 3.2 However, the CLUB informs the adult applicants for a Senior Passport that they may at any time exercise their right to access, rectify and/or cancel said data and/or the treatment of the same by sending a written communication, along with the adult applicant's national ID card, to the party responsible for the file, which is FC BARCELONA, to its business address at Avenida Arístides Maillol, s/n, 08028 Barcelona, or by email to oab@fcbarcelona.cat, stating the justified, specific and express motives and the right that that he/she wishes to exercise.
